ORDER EXECUTION & QUALITY CONTROL

Orders are closely monitored from sampling to shipment by our quality control team. Status on sampling, production and shipment are transmitted to buyers regularly. Our quality monitoring system has four stages as explained below :

- **Pre Production Check** : Risks are reduced by checking material components, accessories / user manuals etc.

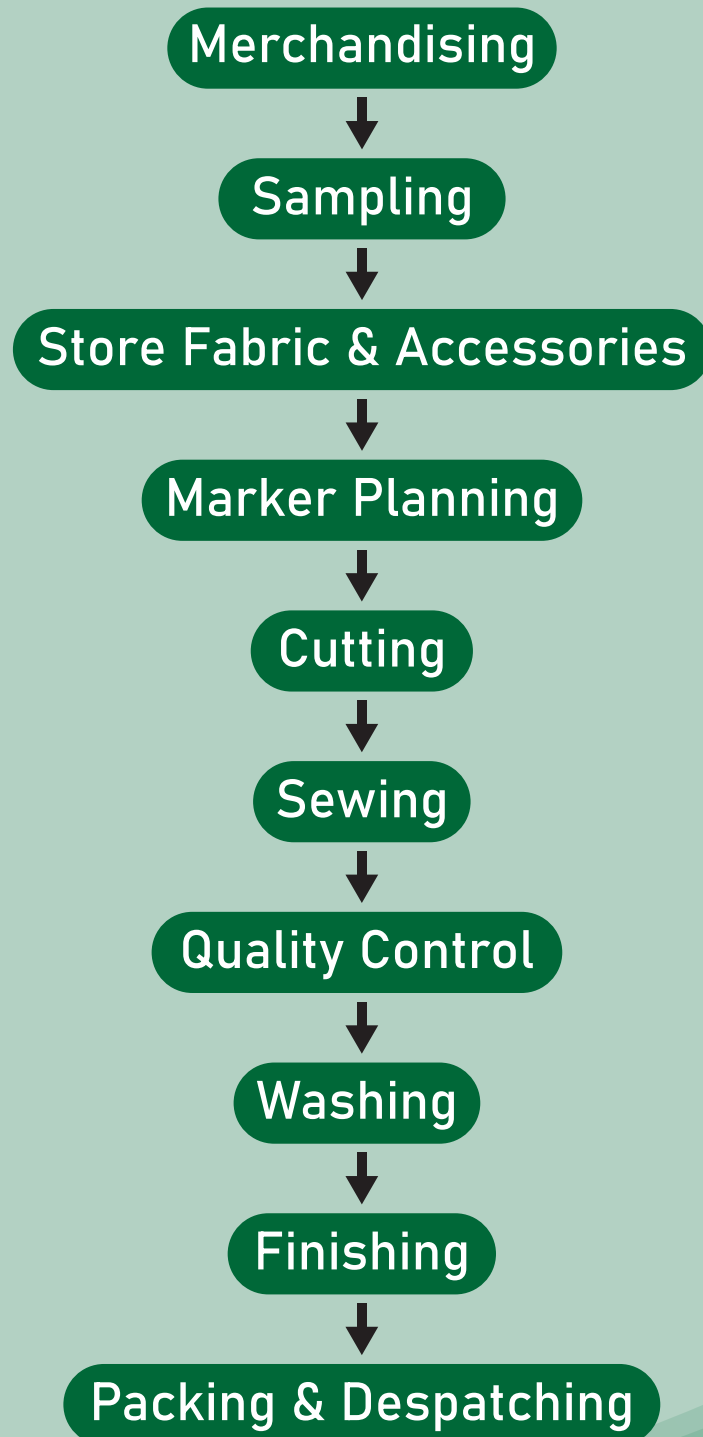
- **Initial Production Check** : First finished products are checked against buyer's specification and prototype sample. Deviations are identified and brought out for correction.

- **During Production Check** : Inspection during production is carried out to check and verify that the initial discrepancies have been rectified and to ensure the quality standard of production runs.

- **Final Random Inspection** : The detailed physical inspection of the samples selected at random is based on specifications of the buyers and it cover the criteria such as design / style, shrinkage, accessories, appearance, markings color, labeling, material, assortments, workmanship, measurements, packing etc.
